Dear FTC Representative:

This is my gift to you. I have been compelled to send you this gift and to write you this letter. I am writing you today regarding the new Business Opportunity Rule, R511993.

- 6) Earnings claims: What about privacy rights?
- 7) Impractical to find “10 nearest existing sales people” – I am helping people in other states and in other countries!

I am already wealthy in spirit, helped others with their health issues and have an opportunity to help others move toward their dreams and financial freedom - as I move toward mine. Please do not sabotage my business and my industry with this rule.
