The requirement to provide a "litigation list" is not at all necessary because if there is any litigation for products it been & will be handled by the Corporation because we pay \$5 towards the **Independent Business Owners Benefits Association (IBOBA) Insurance Program** which cover our risk and we also inform the same to our prospects that every area of concern in this regards is covered by the corporation because in any case the corporation cannot keep records of such litigation pertaining to each IBO and also they cannot update & provide the same on Daily Basis to each one of them.

The requirement for specific earnings disclosures is irrelevant because since the income depends on the work you put in so it is very hard to be accurate and besides that if everyone who are already successful would attract more people then who are joining the team now it would again break the *"Level Playing Field"* law, people who will have bigger income to show will have better chances to get prospect then someone joining in Today.
