I am an independent distributor for SendOutCards.com and I live in your district. I am also the first dot.com member of the Hobart Chamber of Commerce and I am a member of the Business Professional network that meets in Portage, IN at the Holiday Inn Express.

I am writing today about the FTC;s proposed "Business Opportunity" rule (16 CFR Part 437).

I have been with SendOutCards.com for 1 1/2 years. I am concerned because I believe this rule would have a negative effect on my home-based business and (part-time income.

The FTC would require a 7 day waiting period before new Associates can sign up as a Send Out Cards independent distributor.

The FTC would require me to provide the names and telephone numbers of the 10 nearly prior purchasers of the "Business Opportunity" to all potential associates.

The FTC would require me to provide a list of lawsuits filed against the company going back 10 years.

While the FTC;s proposal might be well-intentioned, I believe it is ill-conceived. Please contact the FTC and stop this proposed rule.
