Dear Mr. Yost:

This is in response to your request dated September 18, 2015 under the Freedom of Information Act seeking access to all complaints filed against Trump University LLC, Trump Entrepreneur Initiative LLC, and Trump Organization LLC. You also requested access to the product of any and all previous public records requests "mentioning Donald J. Trump or individuals or entities acting on his behalf."

A previous FOIA request for records pertaining to complaints against "Trump University" and "Trump Entrepreneur Initiative" resulted in 36 complaints filed up until October 24, 2013. Therefore, we have searched our records from October 25, 2013 through September 18, 2015, the date we received your request in our FOIA office.

We have located approximately eight (8) additional responsive complaints that consumers have made to the FTC. I am granting partial access to the accessible records. Portions of these pages fall within the exemptions to the FOIA's disclosure requirements, as explained below.

I am denying access to consumers' names and addresses, and any other identifying information found in the complaints. This information is exempt from release under FOIA Exemption 6, 5 U.S.C. § 552(b)(6), because individuals' right to privacy outweighs the general public's interest in seeing personal identifying information. *See The Lakin Law Firm v. FTC*, 352 F.3d 1122 (7th Cir. 2003).



Please enclose a copy of your original request and a copy of this response. If you believe

that we should choose to disclose additional materials beyond what the FOIA requires, please explain why this would be in the public interest.
