Can you please confirm that it is still the case that for a single transaction where there are two acquiring persons (50/50 owners of the acquiring JV entity), but only one of the acquiring persons will be reporting Item 5 revenue (the other acquiring person has no Item 5 revenue to report), then only one filing fee is due (regardless of whether the acquiring persons choose to submit a joint HSR Form or separate HSR Forms)?
