Appellant Natalia Lynch ("Ms. Lynch"), the Horseracing Integrity and Safety

Authority, Inc. ("Authority"), and the Horseracing Integrity & Welfare Unit (the "Agency")

(collectively, the "Parties") jointly move for withdrawal of this matter from review of the

Administrative Law Judge with prejudice.

On November 10, 2023, Appellant Natalia Lynch ("Ms. Lynch") was served a Notice of Sanctions by the Horseracing Integrity & Welfare Unit (the "Agency") under the Horseracing Integrity and Safety Authority, Inc.'s (the "Authority") Anti-Doping and Medication Control ("ADMC") Program as the result of a final decision issued by Arbitrator Hon. Bernetta D. Bush on November 9, 2023 with respect to two ADMC Program Violations, one for Possession of a Banned Substance under Rule 3214(a) and one for alleged Presence of a Banned Substance under Rule 3212 (the "Imposed Sanctions"). On December 13, 2023, Ms. Lynch appealed the Arbitrator's Final Decision, including the Imposed Sanctions, to the Federal Trade Commission by filing an application for *de novo* review by an Administrative Law Judge.

After a hearing was held but before closing arguments, the Parties reached a full and complete settlement of the matter and entered into a Settlement Agreement (the "Agreement"), dated September 18, 2024.

Accordingly, the Parties respectfully request, as set forth in the Proposed Order attached as Exhibit A hereto, that the Court order the withdrawal of this matter from review by the Administrative Law Judge With Prejudice and that the Court terminate these proceedings.
