JOINT STATUS REPORT

Pursuant to the Court’s Order dated November 15, 2024, Complaint Counsel and Respondents Tapestry, Inc. (“Tapestry”) and Capri Holdings Limited (“Capri”) submit this Joint Status Report advising of the status of the final disposition of this matter.

On November 14, 2024, Tapestry and Capri publicly announced that they had abandoned their proposed transaction that was the subject of this litigation. That same day, Respondent Tapestry withdrew its HSR filing. On November 15, 2024, Complaint Counsel and Respondents jointly moved the Commission to dismiss the administrative complaint (FTC Dkt. 9429). That motion remains pending. On November 20, 2024, upon stipulation of the parties to dismiss the appeal with prejudice, the U.S. Court of Appeals for the Second Circuit issued a mandate withdrawing Tapestry and Capri’s appeal of the decision from the U.S. District Court for the Southern District of New York (*FTC v. Tapestry, Inc. and Capri Holdings Limited*, No. 24-2848 (2d. Cir. 2024)).
