Statement of Chair Lina M. Khan Regarding the Trade Regulation Rule on Unfair or Deceptive Fees Commission File No. R207011

December 17, 2024

Today the Commission finalized a bipartisan rule that prohibits junk fees in the shortterm lodging and live-event ticketing industries.¹ The final rule follows an initiative the Commission launched in 2022 to address unnecessary, unavoidable, or surprise charges that inflate costs while adding little to no value.² The Commission's proposed rule in 2023 elicited over 60,000 public comments, with people recounting their experience navigating junk fees in areas ranging from residential leasing and car rentals to carpet cleaners and payday lending.³ Those comments overwhelmingly supported the use of our rulemaking authority to combat unfair and deceptive fees.⁴ and provided further evidence that junk fees inflate costs, waste consumers' time, hinder comparison shopping, and place honest businesses at a competitive disadvantage. In practice, the final rule means that firms deploying bait-and-switch pricing tactics when selling concert tickets or hotel rooms will be subject to civil penalties and the Commission will be able to return money to harmed customers.

This rulemaking is one piece of a broader Commission effort to combat junk fees. In the last three years, the Commission has taken enforcement action against unfair and deceptive fees at a staggering pace—securing hundreds of millions of dollars in relief for Americans who were

saddled with junk fees.⁵ The Commission's law enforcement actions have spanned a broad swath of the economy, touching on everyday expenses in areas like personal finances,⁶ phone services,⁷ healthcare,⁸ automobiles,⁹ housing,¹⁰ and funeral services.¹¹

Given that junk fees have been a particular pain point for people when buying a car, the Commission separately promulgated the Combating Auto Retail Scams (CARS) Rule to prohibit auto dealers from imposing hidden junk fees or surprise charges buried in lengthy contracts that consumers never agreed to pay.¹² And in light of reports that franchisees were facing a proliferation of undisclosed fees, the FTC issued guidance making clear that franchisors charging junk fees may be violating the law.¹³ Senior FTC leaders have also shared their expertise with state and local policymakers considering bills that would mandate honest pricing and put a stop to junk fees..¹⁴

The final rule will save Americans more than \$11 billion over the next decade and over 53 million hours in time.¹⁵ Yet fully protecting the public from these unlawful pricing practices will require more work. Both the public comments and the FTC's own enforcement experience highlight that junk fees are pervasive across sectors, including in areas like housing—where renters can be on the hook for thousands of dollars more per month than the sum they thought they'd be paying.¹⁶ People budgeting for every-day necessities do not deserve the stress of wondering whether the price they see is honest. And honest businesses should not be punished for abiding by the law.

Importantly, unfair or deceptive fees in sectors that fall outside the purview of this rule can still violate state and federal laws. And both state and federal legislators have introduced a variety of bills to combat junk fees in various corners of the economy, including housing.¹⁷ I urge policymakers to continue building on the FTC's success in challenging junk fees and to guarantee more sweeping protections across the economy. People deserve to know up front what they're being asked to pay—without the endless worry that they'll later be saddled with mysterious fees that they haven't budgeted for and can't avoid.
